**INSTRUMENT OF GOVERNMENT
For**

**The Federated Governing Board of St Andrew's Church of England
(VA) Infant and Junior Schools**

1. The name of the Federation is The Federated Governing Board of St Andrew's Church of England (VA) Infant and Junior Schools.
2. The names of the schools in the Federation are St Andrew's Church of England (VA) Infant School and St Andrew's Church of England (VA) Junior School.
3. Both schools are Voluntary Aided schools.
4. The name of the Governing Board is The Federated Governing Board of St Andrew's Church of England (VA) Infant and Junior Schools.
5. The Governing Board shall consist of
 - (a) 2 parent governors
 - (b) 1 local authority governor
 - (c) 1 headteacher
 - (d) 1 staff governor
 - (e) 7 foundation governors (referred to in paragraphs 7 and 8 below).
6. Total number of Governors is 12.
7. 6 foundation governors, 3 appointed by the Parochial Church Council for The Parish of St Martin's and whose appointment is confirmed by the Leeds Diocesan Board of Education and 3 appointed directly by the Diocesan Board of Education.
8. (a) The holder of the following office shall be the foundation governor ex-officio: The Principal Officiating Minister of The Parish of St Martin's.

(b) The Archdeacon of the Archdeaconry within which the school is situated, shall appoint a substitute to act in the place of the ex-officio foundation governor whose governorship derives from the office named in (a) above, in the event that the ex-officio foundation governor is unable or unwilling to act as a foundation governor, or has been removed from office under regulation 21 (1) of the School Governance (Constitution) (England) Regulations (2012), or there is a vacancy in the office by virtue of which his or her governorship exists.
9. (a) any foundation governor other than an ex-officio foundation governor may be removed from office by the person who appointed the foundation governor.

(b) Any governor so removed and the Clerk to the Governing Board shall be notified in writing by the person referred to in 8 (a).

10. Ethos statement

Recognising their historic foundation, the schools will preserve and develop their religious character in accordance with the principles of the Church of England and in partnership with the Church at parish and diocesan level.

The schools aim to serve their community by providing an education of the highest quality within the context of Christian belief and practice, and promote Christian values through the experience they offer to their pupils.

11. St Andrew's Church of England (VA) Infant School and St Andrew's Church of England (VA) Junior School have a Trust Deed.

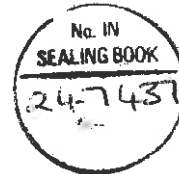
12. This Instrument of Government comes into effect on 16 April 2018.
